

Contest “Winter Fun”
COMPLETE RULES AND REGULATIONS

1. The Contest is being held by the Société des Attractions Touristiques du Québec (hereafter, SATQ) and will take place from December 19, 2018 at midnight to March 15, 2019 at 11:59 p.m. (ET).

ELIGIBILITY

2. This Contest is open to all Canadian and US residents having reached legal age (18 years old), except FL residents, excluding employees and representatives of the SATQ, participating retailers, their advertising or promotional agencies, suppliers of material, prizes or services related to this Contest and any other party directly related to the Contest (sponsors, participating tourist attractions and hotels), and all persons living with such employees, representatives and agents.

HOW TO ENTER

3. To participate, check the Quebec Getaways newsletter, the Quebec Getaways Facebook page or www.quebecvacationguide.com and click on the “Enter Contest” banner, then click on the “Participate” button. A form will appear; fill it out with your first and last names, email address, postal code, phone number and answers.
4. Participation deadline: March 15, 2019, 11:59 p.m. (ET).
5. Each entrant must respect the following participation restrictions in order to avoid being temporarily or permanently disqualified from the Contest:

Limit of one entry per person for the entire length of the Contest.

Limit one email address per person. An email address cannot be used by more than one person. If email addresses are temporarily created in order to participate more than once, the entrant will automatically be excluded from the Contest. The SATQ retains the right to verify all mailing addresses, validity of telephone numbers and/or email addresses in case of doubt or abuse.

6. No purchase required.
7. Odds of winning depend on the total number of entrants.

PRIZES

8. The prize for the Contest is as follows:

A three (3) night stay for two (2) people at one of the 4 Fairmont Hotels & Resorts in Quebec chosen from the Fairmont Le Manoir Richelieu in Charlevoix, Fairmont Le Château Frontenac in Québec City, Fairmont Le Château Montebello in Outaouais or Fairmont Tremblant in the Laurentians), including breakfasts and dinners.

Date when the winners will be announced: March 18, 2019, 2:00 p.m. (ET).
Approximate retail value: \$2,000 (CAD)

Restrictions: reservation required, subject to availability.

 - The prize will come in the form of a gift certificate with an expiration date and restrictions or conditions. It is the winner’s responsibility to check the gift certificate’s restrictions and conditions.
 - The gift certificate for this vacation package may not be exchanged, has no monetary value and may be accompanied by certain other restrictions concerning dates of stay. It is the winner’s responsibility to mention the gift certificate when making a reservation.

DRAWING

10. The Contest drawing will take place in the offices of the SATQ, located at 4545 Pierre-De Coubertin, Montréal (Quebec) H1V 0B2, on March 18, 2019 at 2:00 p.m. (ET).

PRIZE CLAIM

11. In order to be declared the Contest winner, the randomly selected entrant must meet the following conditions:
